These projects typically include curriculum development or presentations to management and may cover new product development, productivity improvements, cost savings, expansion, lead facility changes, etc.</p> <p>Submit a report that includes:</p> <ul style="list-style-type: none"> • The nature of the project. • The projects' time span. • The number of engineers involved. • To whom the final presentation was made. • Results, such as new or improved products, significant cost savings, expansion, etc. • Signatures of at least two individuals of higher management rank for validation.
